Properties

Field of Use

For regular maintenance cleaning of all polished and unglazed vitrified ceramic and porcelain tile surfaces which are subject to normal levels of wear and tear.

Directions for Use

Add one squirt of Lithofin FZ Conditioning Cleaner to a 10 litre bucket of water. Wipe the floor with a wet cloth, then wring out the cloth and wipe again in order to remove the product. Do not walk on the surface until it is completely dry.

<u>Please Note:</u> do not leave the product on sensitive surfaces. In cases of doubt, try the product in an inconspicuous area.

<u>Advice:</u> surfaces which are subject to high levels of wear and tear should occasionally be cleaned with Lithofin FZ Intensive Cleaner. Calcium deposits, rust and soap scum can be removed with Lithofin KF Ceramic-Clean.

Storage

Keep closed, cool and dry. Shelf life of up to five years.
